



## **TOWN OF SURFSIDE LIFEGUARD (Part-Time)**

**DEPARTMENT:** PARKS AND RECREATION

**NON-EXEMPT**

### **GENERAL DESCRIPTION:**

Under the supervision of the Parks and Recreation Aquatic Supervisor and full-time lifeguards, responsible for preventing, recognizing and responding to emergencies at the Town's pools and beach and related recreational activities, and for providing care for injuries and sudden illnesses to their level of certification until advance medical personnel arrive and take over.

### **ESSENTIAL JOB FUNCTIONS:**

1. Active surveillance of swimmers, bathers, weather, and water conditions vigilantly.
2. Performs rescue, artificial respiration, first aid, and emergency work as necessary.
3. Warns against dangerous practices and keeps recognized weak swimmers and non-swimmers out of deep water.
4. Enforces rules and regulations regarding swim areas in a tactful and effective manner.
5. Trains physically to maintain physical abilities to perform duties and pass physical requirements.
6. Notifies proper authorities if public refuses to obey safety rulings.
7. Maintains equipment and performs minor maintenance tasks.
8. Works with the public
9. Participates in regular staff trainings.
10. Completes incident reports.
11. Teaches swim classes.
12. Operates motor vehicle for patrol / rescue. Equipment is both motorized and non-motorized.
13. Performs other duties as assigned.

(These essential job functions are not to be construed as a complete statement of all duties performed. Employees will be required to perform other job-related marginal duties as required.)

### **MINIMUM QUALIFICATIONS:**

#### **KNOWLEDGE, ABILITIES AND SKILLS:**

- Knowledge of water rescue methods and first aid techniques.
- Knowledge of rules and regulations concerning public safety.
- Ability to handle frightened or injured persons in the water.
- Ability to react quickly and calmly and perform effectively in emergency situations.

- Ability to enforce rules and regulations firmly but tactfully.
- Ability to remain alert over long periods of time.
- Ability to maintain effective working relationships with supervisors, employees, and the general public.
- Ability to understand and carry out written and oral instructions.
- Ability to adjust to changing shifts.
- Skill in lifesaving techniques and administering first aid.

**EDUCATION AND EXPERIENCE:**

The required skills would normally be acquired through attainment of specialized training. At least one year of lifeguard experience is preferred.

(A comparable amount of training, education or experience can be substituted for the minimum qualifications.)

**LICENSES, CERTIFICATIONS OR REGISTRATIONS:**

Current American Red Cross Lifeguard Training certification, CPR / AED training certificate and a valid Florida's driver's license are required. Water Safety Instructor (WSI) preferred. Must be able to obtain and maintain certifications as required.

**ESSENTIAL PHYSICAL SKILLS:**

- Acceptable eyesight (with or without correction).
- Vision 20/40 uncorrected
- Acceptable hearing (without hearing aid).
- Ability to communicate both orally and in writing.
- Moderate (15 to 44 pounds) lifting and carrying.
- Swimming.
- Walking.
- Bending.
- Running.
- Paddling.
- Communicate with other employees via telephone and personal contact.

**ENVIRONMENTAL CONDITIONS:**

- Works inside.
- Works out-of-doors in various weather conditions.
- Ultra-violet radiation.
- Pool chemicals.

(Reasonable accommodations will be made in accordance with existing ADA requirements for otherwise qualified individuals with a disability.)
