SPD will implement a new community initiative in partnership with Starbucks – Coffee with the Cops. Residents, business persons, and visitors can meet with the Chief and his staff over coffee to discuss community issues or provide feedback on the Police Department. 150 vehicle report cards were issued in October 2013. 125 vehicles passed and 25 vehicles failed. Officers observed the following in vehicles that failed: backpacks/purses/briefcases, CD's/DVD's, cash and coins, sunglasses, garage door opener, golf club, tools, keys, electronics, bank bag, miscellaneous bags, shopping bags, several cars with windows down, unlocked vehicles and a vehicle with an open trunk.
