## **ORDINANCE NO. 22 - 1726**

AN ORDINANCE OF THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, AMENDING THE TOWN OF SURFSIDE CODE OF ORDINANCES BY AMENDING SECTION 54-78(15) - "PROHIBITTED NOISES" AND SECTION 66-7 - "DISPOSAL OF GRASS CUTTINGS AND HEDGE TRIMMINGS" TO ALLOW OPERATION OF LANDSCAPING EQUIPMENT AND OTHER NOISE-**PRODUCING** MECHANICAL **DEVICES DURING** PERMITTED HOURS; PROVIDING FOR SEVERABILITY: PROVIDING FOR INCLUSION IN THE CODE: PROVIDING FOR CONFLICTS: AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Article VIII, Section 2 of the Florida Constitution, and Chapter 166, Florida

Statutes, provide municipalities with the authority to exercise any power for municipal purposes, except where prohibited by law, and to adopt ordinances in furtherance of such authority; and WHEREAS, the Town Commission of the Town of Surfside (the "Town") finds it

periodically necessary to amend its Code of Ordinances ("Code") in order to update regulations and procedures to maintain consistency with state law, to implement municipal goals and objectives, to clarify regulations and address specific issues and needs that may arise; and

WHEREAS, the Town Commission adopted an ordinance on first reading at its June 14, 2022 Commission meeting to permit residents to perform personal lawn maintenance and operation of landscaping equipment and noise-producing mechanical devices (such as leaf blowers) within certain permitted hours on weekends and federal holidays: and

WHEREAS, Article III, Sec. 54-78. - "Prohibited Noises," of Chapter 54, "Offenses and Miscellaneous Provisions," of the Town Code prohibits noises from any noise-creating blowers or power fans, or any internal combustion engine, which causes noise due to the explosion of operating gases or fluids, unless the noise from such blower is muffled and such engine is equipped with a muffler device; and

WHEREAS, Article I, Sec. 66-7. - "Disposal of grass cutting and hedge trimmings," of Chapter 66, "Solid Waste," absolutely prohibits the use of power blowers to dispose of grass cuttings and hedge trimmings; and

22	WHEREAS, the Town Commission desires to amend the Code to permit landscaping
23	equipment and noise-producing mechanical devices (such as leaf and power blowers)
24	landscape or maintenance of property, within certain permitted hours of operation; and
25	WHEREAS, the Town Commission finds that the restrictions on the use of
26	landscaping equipment and noise-producing mechanical devices (such as leaf and power
27	blowers) has caused health and quality of life issues for many of our residents and has
28	caused additional financial impacts; and
29	WHEREAS, the Town Commission finds it to be in the best interest of the public,
30	health, safety, and welfare of its residents to adopt the Ordinance amending the Town's
31	Code to permit landscaping equipment and noise-producing mechanical devices (such as
32	leaf and power blowers) within permitted hours of operation: and
33	WHEREAS, on July 12, 2022, the Town Commission held its first reading of the
34	ordinance and directed staff to further modify the ordinance to allow for the temporary use
35	of gas-powered leaf and power blowers and to provide for a transition and phase-in period
36	from gas-powered leaf and power blowers to electric and battery-operated blowers of 18
37	months, with a six-month warning period, before the use of gas-powered leaf and power
38	blowers is prohibited; and
39	WHEREAS, the Town Commission finds that this Ordinance is in the best interests of

45 46 47	Section 1. Recitals. The above Recitals are true and correct and are incorporated herein by this reference:

63	(15) Blowers. The operation of any noise-creating blower or power fan, o		
64	any internal combustion engine, the operation of which causes noise due to		
65			
66	or fan is muffled and such engine is equipped with a muffler device sufficient		
67	to deaden such noise, except that landscaping equipment and noise-		
68	producing mechanical devices, including, but not limited to leaf and power		
69	blowers, shall be allowed permitted during the permitted hours of operation		
70	provided in Section 54-78(7). Notwithstanding subsection (7) and this		
71	subsection (15), commencing on March 1, 2024, the use of gas-powered leaf		
72	and power blowers shall be prohibited within the Town, and only battery and		
73	electric-powered leaf and power blowers shall be permitted. The following		
74	educational and enforcement provisions shall be applicable to the transition		
75 76	or phase-in period from gas-powered to electric and battery-operated lear		
70 77	and power blowers:		
78	a. Beginning on September 1, 2022 and extending through March 1		
79	2024. the Town shall engage in an 18-month public education		
80	effort to inform residents and commercial or hired landscape		
81	contractors of the provisions of this Article and the required		
82	transition from gas-powered to electric and battery-operated lear		
83	and power blowers, by the deadline of March 1, 2024;		
84	b. Beginning March 1, 2024, the Town shall provide for a 6-month		
85	warning period through and including September 1, 2024, during		
86	which the code compliance department shall issue written		
87	warnings for violations of this subsection for the continued use of		
88	gas-powered leaf and power blowers; and		
89	c. After September 1, 2024, all enforcement by code compliance		
90	shall be in accordance with Section 54-80 of this Article.

\*\*\* 96 97 **ARTICLE I. - IN GENERAL** 98 99 Sec. 66-7. - Disposal of grass cuttings and hedge trimmings. 100 101 All grass cuttings and hedge trimmings that are not mulched or composted, 102 shall be placed in plastic bags and securely tied before setting out at curbside for 103 collection on the scheduled pick up day up to the allowable four cubic yard limit. If 104 more than four cubic yards is placed at curbside, the town will hang a non-105 compliance notice on the property owner's door and the town will charge a per cubic 106 107 yard fee over the allowable limit as adopted by resolution. Said fee will be billed to the property owner in the monthly utility bill. Commercial gardeners shall promptly 108 remove the cuttings and trimmings from the town. Grass cuttings shall be 109 completely removed and cleaned from all paved areas by broom sweeping only, 110 and the use of power blowers is absolutely prohibited. Grass cuttings may be 111 removed by the use of leaf or power blowers in accordance with the provisions of 112 113 Sections 54-78(7) and 54-78(15) of this Code, provided, that, commencing on 114 March 1, 2024, the use of gas-powered leaf and power blowers shall be prohibited 115 within the Town, and only battery and electric-powered leaf and power blowers shall 116 be permitted. 117 118 119 Severability. If any section, sentence, clause or phrase of this Section 3. Ordinance is held to be invalid or unconstitutional by any court of competent jurisdiction. 120 then said holding shall in no way affect the validity of the remaining portions of this 121 122 Ordinance. 123 Section 4. Inclusion in the Code. It is the intention of the Town Commission, and it is hereby ordained that the provisions of this Ordinance shall become and made a part of 124 125 the Town of Surfside Code of Ordinances, that the sections of this Ordinance may be renumbered or re-lettered to accomplish such intentions; and the word "Ordinance" may be 126 changed to "Section" or other appropriate word. 127 128 Conflicts. Any and all ordinances and resolutions or parts of 129 Section 5. 130 ordinances or resolutions in conflict herewith are hereby repealed. 131 132 Section 6. Effective Date. This ordinance shall become effective upon adoption 133 on second reading. 134
