Building Department

- The Building Department has filled in the vacancies for the Permit Technicians.
- In order to expedite structural building review and approval, the Building Department has hired a part time Structural Plans Examiner for in-house digital plan reviews. This individual is licensed Structural Professional Engineer (P.E.) dedicated to structural plans review only and not tasked with any other structural design responsibilities. This will result in a significantly reduced turnaround time for structural building reviews and improved service levels to our customers.

- The Maintenance Division has started installing turtle friendly lighting on the hardpack. The Towns portion of the project is expected to be completed by mid-March 2023.
