### **Public Works Department**

- The Utilities Division Water & Sewer has started its yearly stormwater structure cleaning; 60 of 98 stormwater structures cleaned. All structures and control boxes are expected to be cleaned and inspected by the first week of April 2023.
- The manhole rehabilitation project will begin repairing the remaining 17 sewer structures. Work will start on March 20, 2023 and is expected to conclude in April 2023. The first 32 rehabilitated manholes have reduced the total volume of sewage pumped by 250kgal.
- The Maintenance Division and Operations Manager repaired damaged stormwater inlets in the Downtown and residential areas. Maintenance will continue to perform repairs at stormwater inlets throughout town prior to Storm Season.

### **Tourism & Communications Department**

- Tourism and Communications hosted the third Surfside Under the Stars event this Saturday, Shell-A-Bration, at Town Hall/93rd Street
- Tourism and Communications has finalized the design component of the website refresh project and will be sending the document with the reorganization of each departmental home page next week to CGA
- Tourism and Communications Director is working on the agenda for the March 13 Tourist Board meeting which will be released on Monday, March 6, 2023.
