Below is a weekly overview of key administration activities per department for the week of March 13, 2023:

# **Building Department**

- The Building and Legal Departments are reviewing the final pre-construction plans/reports for the Eden South project, for compliance with the Development Order (Resolution) to issue the Foundation-Only construction permit.
- The Building Department is issuing the Demolition Permit for the 12-story structure located at 8995 Collins Avenue, also known as the Surf House. All measures will be taken to ensure compliance with our Construction Sites/Safety Ordinance #2022-1720.
