Below is a weekly overview of key administration activities per department for the week of May 22, 2023:

Building Department

- The Building Department has approved and is prepared to issue the Foundation-Only permit for the construction of a new modern 12 story multi-family building. The new structure will be located at 9011 Collins Avenue, where the building referred to as the Hillcrest once stood. The building will be named Surf Club Residences North.
- The original historic Surf Club Building, has been successfully returned, via an engineered foundation ram-track system, 100 feet back to its original location, per the site plan approval requirements of the Miami-Dade Historical Authority. This 3 million dollar preservation, reinforcement, relocation and return of the original building was necessary to construct the underground garage for the new Seaway Building currently under construction.
