#### **Building Department**

• Due to the continued deterioration of the two vacant multi-family buildings known as Regent Palace Condominiums, located at 9309 and 9317 Collins Avenue, Building Official Jim McGuinness has issued a directive to the owners to prepare for the demolition of both buildings. Specifically, a 7 business day time limit was given for the owners to provide a timeline for demolition of the structures, not to exceed 90 days. Failure to comply with this directive will result in further code enforcement action, including but not limited to, assessment of fines and penalties. No adverse impact to neighboring structures as well as protection of pedestrian safety while using the beach access was thoroughly discussed.
