

Town of Surfside Election on Tuesday March 16, 2010

The Town of Surfside will hold its general municipal election on Tuesday March 16. The polling place will be Surfside Town Hall, 9293 Harding Ave in the Commission Chambers on the Second Floor. Polls will be open 7 a.m. to 7 p.m.

Absentee ballots may be obtained by applying in writing to Miami Dade Elections, 2700 NW 87th Avenue, Miami, FL 33172. Absentee ballot requests must be received by the Elections Department by March 10, 2010. Absentee ballots must be returned to Miami Dade Elections and will not be accepted at Town Hall.

The ballot will consist of two races. One race will be entitled **Mayor, vote for one.** The other race will be entitled **Town Commissioner, vote for no more than four.** Note that this is a change to previous years as voted in November, 2008. Please remember to vote for **FOUR** candidates in the Commissioner race. Previously each Town Commission was elected by seat.


Public Works Repairs Seawall

Charles Burkett



Charles W. Burkett (Incumbent), 48, was born in Miami Beach and moved to Surfside in 1995. Charles graduated from the University of Miami and began as a preservationist, renovating art-deco properties on Miami Beach. The Federal Government has recognized many of his properties as Historic Renovation Projects. Development and preservation through the restoration of older and historic properties is his only occupation. He served as a Miami Beach Chamber of Commerce Board Member and Chairman of its Code Enforcement Committee. He served on Miami Beach's Nuisance Abatement and Community Development Block Grant Boards, allocating funds to organizations like Meals on Wheels and Log Cabin Nursery for the disabled. He served as Commissioner of the Miami Beach Housing Authority for eight years, four as Chairman. There he managed a \$22 million budget and staff of 40. He was a founding supporter of the Surfside Coalition following the elections of 2004, and has been active with the Miami Beach Police Athletic League and Citizens Police Academy. Charles is the proud single father of William Michael Burkett, 6 and is completing his second term as the Mayor.

Daniel Dietch



Daniel Dietch and his wife, Dana Kulvin, have lived in Surfside for ten years. They are raising two children who attend Ruth K. Broad Bay Harbor K-8 Center. Daniel is committed to public service in Surfside and the surrounding community. He has served on Surfside's Planning & Zoning Board for six years and the Design Review Board for two years. He was elected to chair these Boards two years ago. He is also a Cub Scout Den Leader. Daniel works as a consultant at CH2M Hill, an environmental consulting firm. He consults with municipalities like Surfside providing financial and strategic planning services and developing policy solutions. In 2008, his work was recognized by Collier County who presented him with a Strategic Planning Award for managing the development and implementation of their 50-year integrated solid waste management strategy. Daniel also serves on the Board of Recycle Florida Today and for the past four years has chaired the Planning and Management Excellence Awards for the Solid Waste Association of North America.

A Surfside resident and homeowner since 2001, Commissioner Calderon was first elected to the Town Commission in 2008. She serves as the Commission's liaison to the Planning and Zoning Committee. She began her professional career as a registered nurse, a graduate of Bellevue Hospital and New York University. She worked for 12 years as a nursing administrator, then attended law school at night and graduated from George Washington University Law School in 1993. Today, she is an attorney specializing in immigration law. She has been admitted to the Bar Associations of the District of Columbia, State of Pennsylvania, Federal District Court for the District of Columbia and Bar Association of the United States Supreme Court. Commissioner Calderon loves reading and is an active member of the Surfside Book Club. She has two adult children. Together with her dog Marseilles, Commissioner Calderon enjoys walking the streets of Surfside every day.

Joe Graubart



Joe Graubart was born in Wilkes-Barre, Pennsylvania and has lived in Surfside since age of six - when his parents, Samuel and Shirley, and brother David moved here in 1956. He was a Cub and Boy Scout in Surfside and attended Bay Harbor Islands Elementary, where he has also served as a volunteer. Joe is also an alumnus of Nautilus Junior High and Miami Beach Senior High Schools. He received a Bachelors Degree from Florida International University in 1975. During his college years at FIU, Mr. Graubart opened a small leather shop on the coast of Maine and eventually owned and operated gift shops for 25 years on the coasts of Maine and New Hampshire seasonally (Memorial Day - Labor Day), while living in Surfside the remainder of the year. In 1998, Mr. Graubart returned to live in Surfside year-round. He has served as Chairman of the Town of Surfside Planning and Zoning Board for four years under two administrations. He currently is a member of the Surfside 75th Anniversary Committee.

Richard lacobacci was born in Duluth, Minnesota. After high school, he attended the carpenter apprenticeship program in St. Lake City, Utah. Michael has been involved in the pharmaceutical industry for over 25 years. He is a Physician's Assistant with Bachelor's degrees in Physiological Psychology and Medicine from the University of Florida. He also has a Ph.D in Health Services Administration from Walden University. For nine years Michael was research director of one of the first private clinical trial study centers in South Florida specializing in Alzheimer's Disease. He joined IVAX Corp. 19 years ago and after IVAX was acquired by Teva Pharmaceuticals, he was promoted to Director, Patient Registries and oversees various research projects and a multimillion dollar budget. Michael moved to Miami 42 years ago from New York. He grew up in North Bay Village and attended Nautilus and Miami Beach High. He's married for 23 years and has a 20 year old son attending FIU. In 1999 he found his dream home in Surfside and calls it his slice of paradise. He is a frequent attendee at Commission meetings and a former member of the Charter Review Board.



Mr. Kopelman was born in Boston and attended the New Preparatory School in Cambridge. 
- Voted to oppose HB 119 which would supersede Town of Surfside Sex Offender Ordinance

First City Hall is the Center of Early Surfside

Soon after incorporation, the first Surfside Town Hall was built and stood at 9550 Harding Avenue. Within the town hall was an 11-man police department and threeman fire department. This fire house would eventually reach a force of 39 paid and volunteer firefighters. There was also a council chambers and jail. This town hall stood as the center of government for twenty years. In 1957, a new Town Hall was constructed in its present location at 9293 Harding Avenue. The old Town Hall, in the center of the bustling business community, was sold for enough to pay for the construction of the new building. This building was completely renovated in 2001. Today, Surfside contracts with Miami-Dade County for its fire services. The closest fire house is located over the Haulover Bridge at

Haulover Park. Within the Town Hall are meeting rooms, offices, the Police Department and the state-of-the-art Commission Chambers.

Seth H. Bramson, honorary member of Surfside's 75th Anniversary Celebration committee is Adjunct Professor of History at both Barry University and FIU and is the author of 17 books on South Florida



local and Florida transportation history including "33154: The Story of Bal Harbour, Bay Harbor Islands, Indian Creek Village and Surfside."
